Subject: Forthcoming semi-annual meeting

As most members already know, the Committee will convene in Washington, D.C. Thursday evening, 2 August, at Thurston Hall of The George Washington University, 1900 \*F\* Street, N.W. This will be the Committee's headquarters throughout our stay. Lodging and meetings will be there. Meals will be available at adjacent university dining facilities, except on Saturday and Sunday, the 4th and 5th, when these facilities will be closed and public restaurants nearby will be available.

Air-conditioned single- and double-occupancy rooms with private baths will be available. Rates are \$9.00 and \$7.00 per diem respectively. Weekly rates are \$40.00 and \$30.00 respectively. For those who, in fact, stay for more than four nights the weekly rate will automatically apply retroactively. Length of stay need not be indicated, but the type of accomodation should be shown. Names should be in Craig's hands by the 15th prox.

Order of discussion is not intended to be fixed, and can be firmly established on Friday morning, the 3rd, which has been deliberately set aside to provide members an opportunity to meet informally and to settle preliminaries. The only present scheduling commitment is one for Saturday afternoon, the 4th, when Burton Neuborne, Esq., Mr. Melvin Wulf's deputy from the national office of the A.C.L.U., will speak on techniques for getting into the Federal Courts in the light of Younger v. Harris. Suggested topics are listed below.
