The **Sexual Law Reporter** is a legal periodical published by the Sexual Law Reporter, a non-profit corporation. The SLR has been published on a bi-monthly basis since April 1975 with the assistance of The National Committee for Sexual Civil Liberties and more recently with the assistance of The Playboy Foundation. Starting in 1978 the SLR will be published on a quarterly basis.

**Typical contents** of an SLR include reports of current developments in sexual law involving legislation, court cases, and administrative rulings, as well as original articles on subjects such as rape, transsexuals, abortion, prostitution, homosexuality, and alternative lifestyles; also law review articles of special interest and book reviews as space permits; special issues feature reprints of the texts of noteworthy reports and decisions handed down in landmark cases.

**SLR subscribers include** the leading law schools, municipal and governmental libraries, attorneys, judges, professors, law students, counselors, therapists, civil liberties and research organizations, as well as professionals from such disciplines as medicine, political science, psychology, theology and sociology.
