As most members already know, the Committee will meet from Thursday evening, 30 June, through Monday evening, 4 July, at the Imperial House Arlington, 1335 Dublin Road, Columbus Ohio. A block of rooms has been reserved at this hotel, and those planning to attend need merely make their intentions known by returning the enclosed reservation card to the hotel.
